Watt's Cooking 📟

Twice Baked Potatoes

- Potatoes (6-8 makes about 10-14 halved potatoes)
- 2 cups cheddar cheese
- 2 cups of sour cream
- 4-6 slices of cooked bacon (chopped up/cut up)
- Salt & Pepper to taste
- Begin by piercing your potatoes with a fork in several places. Bake potatoes for an hour at 400 degrees.
- Let cool 10-15 minutes.
- Cut potatoes in half and spoon out potatoes and place in a medium bowl. Min in 1 cup or so of cheese, sour cream (you can use more of less to your liking), cut up bacon and salt & pepper. Mix well.
- Spoon mixture back into potato skins. You usually can fill fewer potatoes than you had if you have them filled a little higher than the skins sides. Throw away excess skins. Sprinkle potatoes with cheddar cheese.
- Bake at 400 degrees for 20 more minutes.
